

PIPER CAMS

To protect your camshaft from moisture it was coated with preservative oil at the Piper factory. This oil must be removed prior to installation using a suitable cleaning solvent such as paraffin. It is important that suitable hand protection is worn prior to, and whilst removing the oil.

Please do not let your choice of hand protection take preference over the recommended hand protection for the cleaning solvent being used.

Even though the preservative oil will not be in liquid form, if suitable hand protection is not worn whilst handling camshafts prior to cleaning, irritation may occur to some sensitive skin types. Eyes may become contaminated by rubbing with contaminated hands. If any of the above circumstances occur, the following safety guidelines as issued by the original manufacturer should be followed.

Skin Contamination.

Promptly wash contaminated skin with a recognised skin cleaner, soap or mild detergent and water. If irritation persists after washing seek medical advice.

Eye Contamination.

If eye contamination occurs, remove any contact lenses immediately and flush eyes with plenty of clean water for 15 minutes with eyes wide open. Eyelids should be held away from eyeballs to ensure thorough rinsing. Do not re-use contaminated contact lenses. If irritation continues after washing seek medical advice immediately.

This is not a complete or an official Safety Data sheet for the preservative oil used and should not be treated as such.
